



DOCUMENT INSPECTION CERTIFICATE (AV)

DEFINITION	<p>Imports with an FOB value of less than or equal to one (1) million FCFA, and certain other products (see list of goods not subject to RFCV on the website www.douane.ci) are exempt from RFCV procedure.</p> <p>The Customs Department of Risk Analysis, Intelligence and Value (DARRV) examines the file and issues the Inspection Certificate. (AV)</p> <p>The freight forwarder completes the D41 form and physically deposits it with the transport documents (see list above) at the</p> <p>Form D41 is a sampling permit / authorization given by the importer or forwarder to Customs to take a sample of the goods for the purposes of a quality check or to visually assess the apparent condition of the goods.</p>
PROCEDURE DESCRIPTION	<p>As soon as the goods are loaded and all the transport documents for the goods are available (Final Commercial Invoice, Bill of Lading or Air Waybill, Packing List, Freight Invoice, copy of the FDI and all other available certificates), the freight forwarder must initiate a Request for Certificate of Value.</p> <p>The authorized freight forwarder completes Form D41 (Sampling Permit; this is an authorisation given by the importer or freight forwarder to Customs to take a sample of the goods for the purposes of a quality check or to visually assess the apparent condition of the goods) and physically deposits it with the transport documents (Cf. List above) at the Customs Department of Risk Analysis, Intelligence and Value (DARRV) for verification.</p> <p>After examining the file, the DARRV issues an Inspection Certificate (AV).</p>
