



DOCUMENT COCOA COFFEE EXPORT APPROVAL

DEFINITION	<p>Under Ordinance O2011.481, coffee and cocoa exports are reserved for companies incorporated under Ivorian law, professional organisations whose purpose is to export coffee and cocoa, and producers of these products in Côte d'Ivoire (art. 6).</p> <p>In order to export, these operators must hold a valid licence issued by the body responsible for monitoring the sector, the Coffee and Cocoa Council.</p> <p>The conditions required to be able to apply for approval as a cocoa coffee exporter, and the formalities to be completed to obtain it, are set out in Decree 2012.1010 regulating the profession of cocoa coffee exporter.</p>
PROCEDURE DESCRIPTION	<p>The profession of exporter of Coffee or Cocoa and their by-products is subject to obtaining technical approval from the Ministry of Agriculture, issued by the Coffee and Cocoa Council (Decree 2012.1008).</p> <p>Any operator wishing to export coffee or cocoa and their by-products must first apply to the Conseil Café Cacao for export approval.
