



DOCUMENT PRIOR IMPORT AUTHORISATION (API) FOR LIVE ANIMALS

DEFINITION	<p>The right to import live animals for the purpose of exploiting them in Côte d'Ivoire is reserved for persons and companies holding an Authorisation to practise the profession of livestock merchant/livestock broker/livestock butcher and slaughterhouse/retailer issued by the Ministère des Ressources Animales et Halieutiques (MIRAH)/ Direction des Productions d'Élevage/ Sous-Direction de l'Approvisionnement et de la Réglementation des Marchés (Department of Livestock Production/ Supply and Market Regulation Sub-Directorate).</p> <p>Imports themselves are subject to prior import authorisation from the Ministry of Animal and Fisheries Resources (MIRAH) and are issued by the Livestock Production Department (DPE) / Supply and Regulation Sub-Directorate. des Marchés.</p>
PROCEDURE DESCRIPTION	<p>The Procedure is manual.</p> <p>The importer goes to the Sub-Directorate of Supply and Market Regulation (SDARM)/Directorate of Livestock Production (DPE) of the Ministry of Animal and Fisheries Resources to deposit:</p> <ul style="list-style-type: none">• FDI number.• - Copy of invoice.• - Copy of professional licence.• - Ministry form to be completed.• - DPE agents will examine the file and process it.
