



DOCUMENT EXPORT/IMPORT CERTIFICATE

DEFINITION	<p>Export Certificate: Document that accompanies the export of goods to a third country, not forming part of the Community customs territory.</p> <p>Import Certificate : Document that accompanies imports of goods from third countries that are not part of the Community customs territory. Used for statistical purposes, the import certificate is one of the documents in the direct debit file. It is stamped by customs as soon as the goods arrive and is given to the bank for clearance of the direct debit file.</p>
PROCEDURE DESCRIPTION	<p>If the value of the goods to be exported is equal to or greater than ten (10) million FCFA, an Export Certificate - and a Foreign Exchange Undertaking - are required to validate the Export Declaration with Customs - Cf. WAEMU Regulation 09/2010/CM.</p> <p>The Export Certificate and the Exchange Commitment are established online via the transactional site of the Foreign Trade Single Window (GUCE). Access to the site requires prior registration as an importer, exporter or freight forwarder.</p>
