

DOCUMENT CARGO TRACKING SHEET (CBS) FOR IMPORT BY SEA

DEFINITION	The Bordereau de Suivi de Cargaison (BSC) is an electronic tool for monitoring and managing Ivorian maritime trade. The BSC is also an anticipatory and facilitating document that enables shippers to anticipate the exit procedures for their goods, thereby reducing port crossing times and costs. It is compulsory and required for all Import declarations for goods arriving by sea (see Customs Circular 2006-1317/ MDPMEF/DGD dated 13/05/2006). The Office Ivoirien des Chargeurs (OIC) is responsible for managing the BSC. Registration and issuance of this document are carried out online via the OIC website www.oic.ci.	
PROCEDURE DESCRIPTION	The exporter and/or his forwarding agent at the port of shipment and the importer must register the Cargo Tracking Note (BSC) for the goods (1 BSC per Bill of Lading) on the website of the Office Ivoirien des Chargeurs (OIC) when the goods are loaded. The procedure for issuing the BSC is described in detail on the OIC website (www.oic.ci).

DELIVERY TIME	The OIC takes less than a day to analyze a BSC after it has been submitted. This estimate takes into account the processing time from the date and time the BSC is submitted for validation online by its creator until the Technical Centre assigns a status to the BSC after analyzing the documents.

- Certificate of Insurance local to Côte d'Ivoire.
- The Import Declaration Form (FDI) or its number.
- In addition, for imports from countries outside the European Union, the following are required:
 - o Freight Invoice,
 - o the Certificate of Origin.
