

DOCUMENT EXPORT AUTHORIZATION FOR COCOA OR DEFINITIVE FORMULA F01

DEFINITION	The export authorization or F01 "Definitive Formula 01" is issued by the Cocoa-Coffee Council at the time of export. This authorization and the following documents are required to validate the customs declaration - A copy of the exporter's authorization. - The "Formula 01" bulletin or Export Authorization (F01) issued by the Cocoa-Coffee Council. - The Bulletin de Vérification (B.V) issued by ACE-CI. - Empotage Authorization (AE) issued by the Conseil Café Cacao. - The Certificate of Origin (SGP or EUR1), issued by the Chamber of Commerce and Industry (CCI-CI).	
PROCEDURE DESCRIPTION	The exporter or forwarder presents the Transit Order and the royalty and professional contribution cheques to the Cocoa Coffee Council, together with other documents (see list of required documents) in order to obtain an Export Authorization (F01). These fees are based on the theoretical weight (http://www.conseilcafecacao.ci/docs/2015/COMMERCIALISATION.pdf).	
STATE STRUCTURE(S) INVOLVED	The Cocoa-Coffee Council	
COST	There is no cost for export authorization. However, the application must be accompanied by royalty cheques and professional fees, which are based on the theoretical weight. The amount of royalties and professional contributions are available on the Conseil Café-Cacao website.	
DELIVERY TIME	Within half a day.	
DOCUMENTS REQUIRED TO APPLY	 Provisional form edited from the system by the exporter. Coffee and Cocoa Council royalty cheques. Cheques for payment of the registration fee. Copies of product verification bulletins. Transit order.
