The exemption is subsequently reduced:

In the second year before the last year of the approval period, 75% of the duties normally due;

The penultimate year of the approval period has 50% of the duties normally due;

— The last year of the approval period has 25% of the duties normally due.

Art. 12. — The Minister of Industry and Trade, the Minister Delegate to the Prime Minister, in charge of the Economy, Finance and Planning, the Minister of Employment and Civil Service and the Minister of the Environment and Tourism shall be responsible, each in his or her own area of responsibility, for the execution of this decree which shall be published in the Official Journal of the Republic of Côte d'Ivoire.

DECREE no. 96-01 of 3 January 1996 liberalizing the importation of used passenger cars.

THE PRESIDENT OF THE REPUBLIC,

On the report of the Minister of Industry and Trade, the Minister of Equipment, Transport and Telecommunications and the Minister Delegate to the Prime Minister, in charge of the Economy, Finance and Plan.

Considering the Constitution;

Considering Law 91-999 of 27 December 1991 on competition;

Considering Decree No. 88-52 of 20 January 1988 prohibiting the importation for sale in Côte d'Ivoire of used vehicles, decommissioned, retreaded or used tyres, inner tubes and used spare parts;

Considering Decree No. 93-313 of 11 March 1993 on the application of Law No. 91-999 of 27 December 1991 on competition, concerning the conditions of entry into Cote d'Ivoire of foreign goods of all origins and sources, as well as the conditions of export and re-export of goods to foreign destinations;

Considering decree n° 93 PR. 11 of 15 December 1993 appointing the members of the Government, as supplemented by Decree No. 95-886 of 21 October 1995 :

Considering Decree No. 93-921 of 30 December 1993 on the powers of members of the Government, as amended and supplemented by Decree No. 95-946 of 13 December 1995;

Considering Decree No. 94-410 of 3 August 1994 on the organization of the Ministry of Industry and Trade;

the Council of Ministers heard,

DECIDES

Article 1 — Passenger cars including station wagons and used racing cars are free on importation

Art. 2. — Notwithstanding this liberalization, the customs clearance of any imported used vehicle must be carried out at the Abidjan Port customs office on presentation of an identification form issued by the Société ivoirienne de Contrôle technique automobile (SICTA).

- Art. 3. This decree abrogates all previous provisions to the contrary, in particular those relating to used passenger cars in decree n° 88-52 of 20 January 1988 prohibiting the importation for sale in Cote d'Ivoire of used vehicles, decommissioned, retreaded or used tyres, inner tubes and used spare parts.
- Art. 4. The Minister of Industry and Trade, the Minister of Equipment, Transport and Telecommunications and the Minister Delegate to the Prime Minister, in charge of the Economy, Finance and Planning, are each responsible for the execution of this decree, which will be published in the Official Journal of the Republic of Côte d'Ivoire.

DECREE No. 95-714 of September 13, 1995 setting the operating rules for local radio stations.

Considering Law No. 91-1001 of 27 December 1991 on the audiovisual communication regime;

Considering Decree No. 92-283 of 21 April 1992 implementing Law No. 91-1001 of 27 December 1991 establishing the audiovisual communication regime:

Considering decree n° /2-397 of 1" July 1992 fixing the rules for the allocation of frequencies to the concessionaires of the national public service of radio and television broadcasting;

Considering Decree No. 92-419 of 15 July 1992 on the organization and operation of the National Audiovisual Communication Council (CNCA);

Considering Decree No. 93 PR. 11 of 15 December 1993 appointing the members of the Government

Considering Decree No. 93-921 of 30 December 1993 on the powers of the members of the Government

the Council of Ministers heard.

DECIDES:

Article 1 — The purpose of this decree, issued in application of the above-mentioned law no. 91-1001 of 27 December 1991, is to set the general operating rules for local radio stations.

Art. 2. — For the purposes of this decree, "community radio" shall be understood to mean any public service radio broadcasting concession granted to a natural or legal person for its management and operation, the essential characteristic of which is the production and broadcasting of radio programmes:

- By radio and in frequency or amplitude modulation, over a geographical area limited to, at most, b. a circle of ten kilometers radius around the transmitter center;
- Whose programme content is exclusively of local interest
