Considering Decree No. 88-52 of 20 January 1988 prohibiting the import for sale in Cote d'Ivoire of used vehicles, decommissioned, retreaded or used tyres, inner tubes and used spare parts;

Considering Decree No 93-313 of 11 March 1993 implementing Law No 91-999 of 27 December 1991 on competition, as regards the conditions of entry into C6te (Moire of foreign goods of all origins and sources, as well as the conditions of export and re-export of goods to foreign countries:

Considering decree no. 96-01 of 3 January 1996 on the liberalization of the import of used passenger cars;

Considering Decree No. 96 PR. 02 of 26 January 1996 appointing the members of the Government as amended by Decree No. 96 PR. 10 of 10 August 1996;

## DECIDES:

- Article 1 Used motor vehicles of all types, intended for public and private transport of goods and personnel, whose age does not exceed ten years, shall be released upon importation.
- Art. 2. Notwithstanding this liberalization, the clearance of any used vehicle referred to in the above article and imported must be carried out at the Customs offices of Abidjan Port and San-Pedro Port on presentation of an identification form issued by the Societe ivoirienne de Controle technique automobile (SICTA)
  - Art. 3. The issuance of the certificate of release for consumption by Customs and the registration of the vehicles referred to in Article 1 shall be subject to obtaining a technical inspection certificate issued by SICTA.
- Art. 4. An interministerial order will determine the terms of application of this decree
- Art. 5. This decree abrogates all previous provisions to the contrary, in particular those relating to second-hand vehicles in Decree No. 88-52 of 20 January 1988 referred to above.
- Art. 6. The Minister of Trade, the Minister Delegate to the Minister of Economic Infrastructures, in charge of Energy and Transport, and the Minister of Economy and Finance, are responsible, each in his or her area of responsibility, for the execution of this decree which will be published in the Official Gazette of the Republic of Cote d'Ivoire.
