DECREE No. 97-340 of 12 June 1997 amending the annex to Decree No. 92-50 of 29 January 1992 regulating competition and prices, amended by Decree No. 96-246 of 13 March 1996.

THE PRESIDENT OF THE REPUBLIC,

On report of the Minister of Trade,

Considering the Constitution.

Considering Law No. 91-999 of 27 December 1991 on Competition.

Considering Decree No. 92-50 of 29 January 1992 regulating competition and prices, amended by Decree No. 96-246 of 13 March 1996;

Considering Decree No. 96 PR. 02 of 26 January 1996 appointing the members of the Government, as amended by Decree No. 96 PR. 10 of 10 August 1996;

Considering Decree No. 96-179 of 1 March 1996 on the powers of members of the Government;

Considering the opinion of the Commission ;

The Council of Ministers heard,

DECIDES:

Article 1. — The annex to Decree No. 92-50 of 29 January 1992 on the regulation of competition and prices, amended by Decree No. 96-246 of 13 March 1996, is amended as follows :

- 1° Tariffs for water, electricity, post and telecommunications utilities ;
- 2° Butane gas;
- 3° Agricultural commodities: indicative prices for coffee, cocoa, seed cotton, rubber;
- 4° Pharmaceutical products and specialities;
- 5° Local edition primary school books;
- 6° Baguette bread.

Art. 2. — The prices of the products and services referred to in Article 1 above are regulated by the Administration.

Art. 3. — Infringements of this decree shall be punished in accordance with the provisions of Law No. 91-999 of 27 December 1991 on competition.

Art. 4. — All previous provisions contrary to this decree are hereby repealed, in particular the annex to decree n° 92-50 of 29 January 1992 on the regulation of competition and prices, relating to the list of products and services whose prices are regulated, as amended by decree n° 96-246 of 13 March 1996.

Art. 5. — The Minister of Trade is responsible for the execution of this decree which will be published in the Official Journal of the Republic of Cote d'Ivoire.

The Council of Ministers heard,

DECIDES :

Article 1. — Annex B of the above-mentioned Decree No. 93-313 of 11 March 1993 on the products subject to the limitation regime is amended as follows:

Petroleum products

- 27.09.00 — Crude oil from petroleum or bituminous minerals;
- 27.10.10. — Partially refined petroleum;
- 27.10.21. — White spirit ;
- 27.10.29. — Other special species;
- 27.10.31. — Aviation gasoline;
- 27.10.32. — Super fuel;
- 27.10.33. — Petrol car ;
- 27.10.39. — Other light oils;
- 27.10.41. — Jet fuel ;
- 27.10.42. — Paraffin;
- 27.10.49. — Other oils
- 27.10.50. — Diesel-oil DDO;
- 27.10.51. — Diesel fuel;
- 27.10.52. Domestic fuel oil;
- 27.10.53. — Light fuel oil;
- 27.10.54. — Heavy fuel oil I ;
- 27.10.55. — Heavy fuel oil II

Rubber and articles thereof

- 40.05.10. — Rubber with added carbon black or silica anhydride;
 40.11.31. — Inner tube for velocipedes; 40.11.51. —
 Tyres for velocipedes;

Cotton fabrics

- 55.09.02. — Plain weave unbleached cotton fabrics ;
 55.09.24. — Bleached cotton basin;
 55.09.41. Dyed cotton basin;

 grams per metre dyed (denim fabrics) ;

Art. 2. — This decree abrogates all previous provisions to the contrary, in particular those of Annex B of the aforementioned decree n° 93-313 of 11 March 1993, relating to second-hand goods and sugars.

Art. 3. — An order of the Minister of Trade shall specify, as necessary, the modalities of application of this decree.

Art. 4. — The Minister of Trade is responsible for the execution of this decree which will be published in the Official Journal of the Republic of Cote d'Ivoire.

DECREE No 97-342 on the liberalisation of the import of declared or used tyres, inner tubes and used spare parts.

Considering Decree No. 88-52 of 20 January 1988 prohibiting the import for sale in Cote d'Ivoire of used vehicles, decommissioned, retreaded or used tyres, tubes and spare parts;

Considering Decree No. 93-313 of 11 March 1993 implementing Law No. 91-999 of 27 December 1991 on competition;

Considering decree no. 96-01 of 3 January 1996 on the liberalisation of the import of used passenger cars;

Considering Decree no. 96 PR. 02 of 26 January 1996 appointing the members of the Government, as modified by Decree no. 96 PR. 10 / of 10 August 1996 ;

Considering Decree No. 96-179 of March 1996 on the powers of members of the Government;

Considering decree no. 97-142 of 7 March 1997 on the liberalisation of the import of used motor vehicles, intended for the transport of goods and persons;

The Council of Ministers heard,

DECIDES :

Article 1. — Decommissioned or used tyres, inner tubes and used spare parts are released for import.

Art. 2. — This decree abrogates all previous provisions to the contrary, in particular those relating to downgraded or used tyres, air chambers and used spare parts of the aforementioned Decrees No. 88-52 of 20 January 1988 and 93-313 of 11 March 1993.

Art. 3. — The Minister of Trade, the Minister Delegate to the Minister of Economic Infrastructures in charge of Energy and Transport and the Minister of Economy and Finance are responsible, each in his or her area of responsibility, for the execution of this decree which will be published in the Official Journal of the Republic of Cote d'Ivoire.
