DECREE No. 2013-179 of 22 March 2013 creating the Department of Taï

Considering Decree No. 2011-263 of 28 September 2011 on the organisation of the national territory into districts and regions;

Considering Decree No. 2012-625 of 6 July 2012 on the powers of the members of the Government;

The Council of Ministers heard,

DECIDES:

Article 1 — Another department was created in the Cavally region by the reorganization of the department of Guiglo, with fixed Taï as its chief town and the sub-prefectures of Taï and Zagne attached to it.

The department of Guiglo consists of the sub-prefectures of Guiglo, Bedy-Goazon, Kaade and Nizahon.

Art. 2. The Minister of State, Minister of the Interior and Security is responsible for the execution of this decree which will be published in the *Official Journal* of the Republic of Cote d'Ivoire.

DECREE No. 2013-221 of 22 March 2013 on the export of non-standard cocoa, cocoa waste and residues.

THE RESIDENT OF THE REPUBLIC,

On the joint report of the Minister of Agriculture, the Minister at the Prime Minister's Office, in charge of the Economy and Finance, the Minister of Trade, Handicrafts and SME Promotion and the Minister of Industry;

Considering Order No. 2011-481 of 28 December 2011 laying down the rules relating to the marketing of coffee and cocoa and the regulation of the coffee and cocoa sector;

Considering Decree No. 2012-06 of 16 January 2012 to name the Management, Development and Regulation Body of the Coffee and Cocoa Sector and to stabilise coffee and cocoa prices;

Considering Decree No. 2012-625 of 6 July 2012 on the powers of the members of the Government;

Considering Decree No. 2012-1011 of 17 October 2012 setting out the conditions for the packaging of cocoa for export,

Considering Decree No. 2012-1118 of 21 November 2012 appointing the Prime Minister;

Considering Decree No. 2012-1119 of 22 November 2012 appointing members of the Government;

The Council of Ministers heard,

DECIDES;

Article premier. — Sont uniquement admis a l'exportation, le cacao hors normes, les (Whets et residus de cacao qui ont fait l'objet de transformation.

Art. 2. — La transformation du cacao hors normes, des dechets et residus de cacao s'entend comme l'operation de leur modifies-don en produits semi-finis ou finis comme le beurre, les tourteaux, la poudre, les composants inergetiques, les granules de coques ou la potasse.

Art. 3. — For the purposes of this Decree, cocoa waste and cocoa residues shall mean:

— by-products of harvesting, podding, fermenting and sorting, including degenerated bean, sprouted bean, mouldy bean, flat bean, clumped bean, micro bean, fragmented bean, black bean, slate bean, mitted bean, any other defective bean and pods;

— by-products of packaging, handling, transport and other storage sweepings, including micro-breaks, dust, flat beans, microbeans;

— industrial waste from cocoa bean processing units, i.e. cake, powder, mass, butter, toques.

The above product standards are defined by the Coffee and Cocoa Council.

Any cocoa product other than those listed above is excluded from the scope of this decree.

Art. 4. — The collection and processing of the products referred to in Article 3 above are carried out by the operators provided for in the decree laying down the procedures for the marketing of coffee and cocoa.

Art. 5. — The Coffee and Cocoa Council shall specify, at the beginning of each marketing year, the conditions for the collection and processing of these products..

It carries out checks on products at all stages of operations, particularly collection, processing and export.

Art. 6. — The export of products resulting from the processing of non-standard cocoa, cocoa waste and cocoa residues is subject to prior approval by the Cocoa Council.

Art. 7. — Any export of finished or semi-finished products mentioned in Paragraph 2 of this decree is subject to the payment of a Single Exit Duty, D.U.S, taxes and fees.

Art. 8. — Failure to comply with the provisions of this decree and the control procedures defined by the Cocoa Council shall expose the offender to the penalties provided for by the regulations in force.

Art. 9. — The Minister of Agriculture, the Minister attached to the Prime Minister, in charge of the Economy and Finance, the Minister of Trade, Handicrafts and the Promotion of SMEs and the Minister of Industry are each responsible for the execution of this decree, which will be published in the Official Journal of the Republic of Côte d'Ivoire.
